- What is the criminal law accident?
- Example of the event.



- In case, you are in the event of car accident.
- In case, you have got hurt or wounded from car accident.
- In case, you are a driver, in this case, don't flee or escape.
- In case, your car has got insurance.
- In case, you have a camera.
- In case, you help the wounded or help for cremation



- Suggestion for criminal lawsuit
 - Put in jail in the district court
 - Put in jail in the criminal court or provincial court
 - When put in jail or shift of accusation

How much of valuable securities?

In case the alleged offender had fled or escaped

The injured person got the serious injury

Valuable securities = 80,000 Baht

The injured person is dead.

Valuable securities = 120,000 Baht

In case the alleged offender did not flee or escape

The injured person got the serious injury
Valuable securities = 30,000-50,000
Baht

The injured person is dead.

Valuable securities = 80,000 Baht



When the court has accepted the charge, if the accused person would like to defend in a legal action, these should be followed:

- 1. Filing for bail out request to the court.
- 2. Find the attorney to help defending in a legal action
- 3. Filing statement of defend to court.

Section 291.- Whoever, doing the act by negligence and that act causing the person to death, shall be imprisoned not out of ten years or fined not out of twenty thousand Baht.

Section 300.- Whoever, committing the act by negligence and such act to cause the grievous bodily harm to the other person, shall be imprisoned three years or fined not out of six thousand Baht, or both.

Section 297 Whoever commits the offense of assault causing serious harm to the person being assaulted, shall be punished with imprisonment up to 10,000 baht. Imprisonment from six months to ten years, serious danger is

- (1) Blindness, deafness, missing tongue, or nerve damage.
- (2) loss of reproductive organs or reproductive ability

- (3) Loss of an arm, leg, hand, foot, finger or any other organ.
 - (4) The face is permanently disfigured.
 - (5) Miscarriage
 - (6) persistent mental disability
- (7) Disabled or chronically ill, which may last for life.
- (8) Disabled or sick with symptoms of suffering for more than twenty days or to the extent that he is unable to perform his normal activities for more than twenty days.

Section 56 -Whoever commits an offense which is punishable by imprisonment or a fine And in that case, the court will impose a prison sentence of not more than five years, whether or not a fine is also imposed, or a fine. If it appears that that person

- (1) has never been imprisoned before, or
- (2) has been sentenced to prison before, but the punishment was for an offense committed negligently or a petty offense or is a prison sentence not exceeding six months; or

(3) has served a prison sentence before but has been released from prison for more than five years; Then come and commit another crime. The latter offense was an offense committed through negligence or a petty offense.

In a criminal case, when the court judges that the defendant has committed a crime.

-In a criminal case, when the court judges that the defendant has committed a crime. When the court considers the defendant's various circumstances and when the court takes into account the age, history, conduct, intelligence, education, training, health, mental state, character, occupation, and environment of that person. or fault condition or feeling guilty and try to alleviate the harmful effects that occur. The court may not impose imprisonment on the defendant. There may be an order pending punishment. Or what is known as a suspended sentence or there will be an order waiting to determine the sentence as well.
