

## THAILAND NEW VISA MEASURES



**NOTE: Effective date of the new measures will be announced upon the completion of final legal procedures.**

### Destination Thailand Visa (DTV)



#### Eligible Foreigners

- Remote Workers/Digital Nomads/Freelancers
- Participants of activities such as Muay Thai courses, Thai cooking classes, sport training, medical treatment, seminars, music festivals, etc.
- Spouses and dependent children of DTV holders

#### Period of Stay

**180 days**

(1 time extension of stay at the Immigration Bureau for a period not exceeding 180 days)

**Visa Validity: 5 years  
(multiple-entry)**

**Visa Fee: 10,000 baht**

## Visa Exemption (60 days)

Nationals of the following **93 countries and territories** are entitled to visa exemption for the purpose of **tourism and short-term business engagements**, for a period not exceeding 60 days.

Albania, Andorra, Australia, Austria, Belgium, Bahrain, Bhutan, Brazil, Brunei, Bulgaria, Cambodia, Canada, Czech Republic, China, Colombia, Croatia, Cuba, Cyprus, Denmark, Dominica, Dominican Republic, Ecuador, Estonia, Fiji, Finland, France, Georgia, Germany, Greece, Guatemala, Hong Kong, Hungary, Iceland, India, Indonesia, Ireland, Israel, Italy, Jamaica, Japan, Jordan, Kazakhstan, Korea (ROK), Kosovo, Kuwait, Laos, Latvia, Liechtenstein, Lithuania, Luxembourg, Macao, Malaysia, Maldives, Malta, Mauritius, Mexico, Monaco, Mongolia, Morocco, Netherlands, New Zealand, Norway, Oman, Panama, Papua New Guinea, Peru, Philippines, Poland, Portugal, Qatar, Romania, Russia, San Marino, Saudi Arabia, Singapore, Slovakia, Slovenia, Spain, Sri Lanka, South Africa, Sweden, Switzerland, Taiwan, Tonga, Trinidad and Tobago, Türkiye, Ukraine, UAE, UK, USA, Uruguay, Uzbekistan, and Vietnam



## Visa on arrival (VoA)

Nationals of the following **31 countries and territories** may apply for visa on arrival at the immigration checkpoints on arrival for the purpose of tourism, for a period not exceeding 15 days.

Armenia, Belarus, Bulgaria, Bhutan, Bolivia, China, Costa Rica, Cyprus, El Salvador, Ethiopia, Fiji, Georgia, India, Kazakhstan, Kyrgyzstan, Malta, Mexico, Namibia, Nauru, Papua New Guinea, Paraguay, Romania, Russia, Saudi Arabia, Serbia, Seychelles, Taiwan, Tunisia, Uzbekistan, Vanuatu and Venezuela



# Non –O-X Visa: Requirements

## 1. Age of 50 years old or over

## 2. Applicants must hold passport and nationality of (1) Japan (2) Australia (3) Denmark (4) Finland (5) France (6) Germany (7) Italy (8) Netherlands (9) Norway (10) Sweden (11) Switzerland (12) United Kingdom (13) Canada (14) United States of America

## 3. Financial qualifications

- (a) Applicants must have money deposited in Thai bank located in Thailand with the amount of not less than **3 million Baht**; or
- (b) Applicants must have money deposited in Thai bank located in Thailand with the amount **of not less than 1.8 million Baht** and have income with the amount of not less than **1.2 million Baht per year**.  
Once the applicants enter Thailand, they must have accumulated money deposited in Thai bank located in Thailand **not less than 3 million Baht within 1 year**.

# Non –O-X Visa: Requirements

- The money in (a) and (b) must be kept in bank account **at least 1 year before withdrawing** and,
  - within another next year, the money must be left in the account with the amount of **not less than 1.5 million Baht**
  - and can only be spent in Thailand.

## 4. Applicants must have no forbidden diseases

which include Leprosy, Tuberculosis, Elephantiasis, drug addiction and third stage of Syphilis.

## 5. Applicants must have Thai medical insurance

during their stay in Thailand (per the approval of the Office of Insurance Commission) and medical claims

- for outpatient must not be less than 40,000 Baht,
- for inpatient must not be less than 400,000 Baht.

# Non –O-X Visa: Required Documentation

1. **Passport** must be valid for at least six months from the date of travel.
2. **3 application forms and 3 photographs** (size 4 X 6 cm. taken within the last 6 months)
3. **1 biography**
4. **Financial evidence:**
  - 4.1 **Certificate of bank deposit** stating bank contact information,
    - copy of bank book and bank statement which shows fixed deposit
    - with the amount of not less than 3 million Baht deposited in Thai bank located in Thailand;
  - OR
  - 4.2 **Certificate of bank deposit** stating bank contact information, copy of bank book and bank statement which shows fixed deposit with the amount of **not less than 1.8 million Baht** deposited in Thai bank located in Thailand and
    - **certificate of annual income** with the amount of **not less than 1.2 million Baht** per year.
    - (Once the applicants enter Thailand, they must have accumulated money deposited in Thai bank located in Thailand not less than 3 million Baht within 1 year.)

# Non –O-X Visa: Required Documentation

5. **Certificate of criminal record** clearance from the country of nationality. In case the applicants have permanent residence in other country, they must provide the aforementioned document from both country of nationality and country of permanent residence.

6. **Medical certificate** from the country where the applicants apply visa stating that applicants don't have any prohibited diseases

- which include Leprosy, Tuberculosis, Elephantiasis, drug addiction, third stage of Syphilis.
- The medical certificate must not be issued over 3 months.

7. Copy of evidence stating that applicants **have insurance** as per stipulated by the Office of Insurance Commission and health insurance of Thailand which has insurance money

- for outpatient not less than 40,000 Baht and
- for inpatient not less than 400,000 Baht.

8. Visa fee: 10,000 Baht

# Non –O-X Visa: Required Documentation

**Spouses and children (under 20 years of age) of the applicants can apply for Non-O-X visas and must submit the following required document**

9. Spouse (no age restriction): must provide a copy of **marriage certificate** together with documents in 1 - 8
10. Children (under 20 years of age): must provide a copy of **birth certificate** or the equivalent, together with documents 1 - 3 and 7 - 8

# Non –O-X Visa Benefits

- The purpose of this type of visa is to promote **long stay for foreign traveler** to Thailand.
- Nationals from 14 countries with the age of 50 years old or over can apply for a multiple-entry Non-O-X visa and stay in the Kingdom for the **maximum period of 10 years**
- (5 years according to visa validity plus an extension for another 5 years).
- The visa fee is **10,000 Baht**
