







# THAILAND DIGITAL ARRIVAL CARD : TDAC

## NEW TDAC REQUIREMENT



### All foreign arrivals

Regardless of visa status, all non-Thai passport holders arriving by air, land, or sea will need to fill out the online TDAC.



### Replacing TM6 arrival card

The new TDAC will replace the old manual TM6 arrival card that was often difficult to fill out due to its small size and lack of working pens.



### Required prior to travel

Travelers will need to submit the TDAC online in advance of their trip to Thailand.

The implementation of the TDAC aims to streamline the arrival process for foreign travelers in Thailand, but its success will depend on the government's ability to provide clear and timely information to the public.

## KEY DETAILS OF THE TDAC

### Biographical Information

The TDAC will require travelers to provide their personal details, such as name, date of birth, and passport information.

### Travel Details

Travelers will need to submit their travel itinerary, including arrival and departure dates, flight numbers, and mode of transportation.

### Accommodation Details

Travelers will be required to provide information about their planned accommodation, such as hotel name, address, and contact details.

### Confirmation QR Code

Upon completing the TDAC, travelers will receive a QR code confirmation that they can present to immigration officers or at electronic gates upon arrival in Thailand.

### IMPORTANT NOTICE

In accordance to Immigration Act, B.E. 2522

1. All passengers must complete the Thailand Digital Arrival Card.
2. If the alien stays in the Kingdom longer than 90 days, he/she must notify in writing the nearest Immigration Officer, concerning place of stay as soon as possible upon expiration of 90 days. And required to do so every 90 days.
3. Aliens are not allowed to work unless they are granted Work Permit.

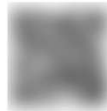

Please note that the Thailand Digital Arrival Card is not a visa. You must still ensure you have the appropriate visa or qualify for visa exemption to enter Thailand.

## UNANSWERED QUESTIONS

- **Consequences for non-compliance**

It is unclear what the consequences will be for travelers who fail to submit the TDAC prior to their arrival in Thailand,

- such as being denied boarding or facing penalties upon arrival.

- **Requirement for every visit**

It is uncertain whether the TDAC will be required for **every visit** to Thailand,

- or if it will be a **one-time submission** for a certain period of time.
